

## NOTICE OF FILMING, PHOTOGRAPHY & ADVERTISING

1. When you enter the event grounds of SpeedBay, you enter an area where photography, audio, and video recording may occur.
2. By entering the event premises, you consent to interviews, photography, audio recording, and its/their release, publication, exhibition, or reproduction to be used for news, web casts, promotional purposes, telecasts, product and event advertising, inclusion on websites, social media, or any purpose by the Organisers and its affiliates and Sponsors. Images, photos and/or videos may be used to promote similar events in the future and/or product advertising for event Sponsors.
3. You release the Organisers and its Sponsors, and jointly their officers and employees, and each and all persons involved from any liability connected with the taking, recording, digitizing, or publication and use of interviews, photographs, images, video and/or sound recordings.
4. By entering the event premises, you waive all rights you may have to any claims for payment or royalties in connection with any use, exhibition, streaming, web casting, televising, or other publication of these materials, regardless of the purpose or sponsoring of such use, irrespective of whether a fee for admission, participation, or sponsorship is charged. You also waive any right to inspect or approve any photo, video, or audio recording taken by the Organisers or the person or entity designated to do so by the Organisers.
5. You have been fully informed of your consent, waiver of liability, and release before entering the event.
6. Competitors will be obliged to carry official event stickers and sponsor logos on the karts, race suits and helmet. Any such advertising material will be provided by the Organisers along with instruction on positioning as necessary.
7. Prize winners may be obliged to wear a sponsor cap, if supplied by Race Organisers, during the award presentation.
8. All drivers receiving awards at the post-race presentation should wear their race suit (zipped up with collar fastened) and race boots. Failure to comply with the Organiser's instructions could lead to exclusion from the results/event.
9. Competitors are allowed to bring individual photographers/videographers or companies, production houses, media, or media agencies to document their participation in the event. However, when publishing or sharing any content related to their participation, competitors must incorporate the logos and content provided by SpeedBay. No other brand logos or promotional content are permitted in any media coverage or promotional materials related to the event, apart from those provided by SpeedBay.
10. Photographers and videographers must register at the registration desk and obtain their high-visibility jackets before commencing their work. They should always remain in the designated safety zones when taking on-track or paddock shots.
11. SpeedBay reserves the right to review and approve all media coverage and promotional materials related to the event to ensure compliance with these regulations.

12. Abusive comments on any social media platform (Facebook, Instagram etc.) or public forum are completely forbidden. This applies to competitors, officials, Organisers and any person associated with the series and the sport in general. Competitors are strongly advised to guard against participation in contentious, divisive and potentially damaging conversations and will be held liable for their actions.
13. Further to above, social media posts relating to the Event or Venue, or any element therein, must be proactive, informative or positive. Competitors and associates should avoid posting negative comments about anyone other than themselves. Any party in breach of this rule is liable to bring the series and, by association, the sport into disrepute. Action will be swift on such matters and could result in expulsion from the Championship for the offender, whether individual, mechanic, circuit or official. In the case that the offender is not a registered competitor, action may be taken against any party associated with the offender.
