

GENERAL CONDITIONS OF SALE

ONLINE -

IAME SERIES BENELUX

Art.1 - KC MARIEMBOURG-ASBL

Karting Des Fagnes ASBL, Rue du Karting 13, 5660 Mariembourg is registered at the BCE under the number 0449.402.087 and is the operator of the IAME SERIES BENELUX Karting Championship

Art.2 - Access conditions

The events of the IAME SERIES BENELUX are reserved for people who have previously registered their entry online on the website www.iame-motorsport.com and who accept the general conditions of sale and the regulations governing the events.

Art.3 - Fees & Refund Policy

The management reserves the right to modify its rates at any time, without prejudice to the validity of the tickets reserved and paid before this modification. Except in cases of force majeure, KC Mariembourg informs its customers continuously via the website www.iame-motorsport.com. This site includes the schedules and all the organizational details with a minimum of 2 weeks visibility before each event. Additional announcements are made regularly via Facebook posts. This mode of information aims to limit as much as possible any last minute changes in the program, the KC Mariembourg cannot be held responsible for reimbursing tickets that cannot be honored because of late changes, or changes that have not been announced by these 2 information channels. Unless otherwise agreed in writing, tickets will not be exchanged or taken back, even if they are not used by the final beneficiary or if the organization sites have been rendered inaccessible in any way whatsoever, including bad weather, fortuitous events, and this without these being considered as "force majeure". Even in the case of a case of force majeure in the legal sense of the term, the only obligation incumbent on KC Mariembourg will be to offer the visitor a new date for the use of the ticket purchased.

Art. 4

The tickets purchased are nominative and may not be resold. The attempted sale or use of an irregular title, in addition to the fact that they are liable to criminal prosecution, will immediately result in the confiscation of the said title, without the possibility of reimbursement and without prejudice to compensation for the entirety of the damage suffered.

Art.5 - Respect of intellectual property

No plagiarism of any part of the website, Facebook posts, Folders and other publications of KC Mariembourg are allowed. The purchase of a right of access does not allow for the reproduction or distribution of a copy of any of KC Mariembourg's communication elements without prior written authorization.

Art.6 - Protection of privacy

The rules relating to the protection of personal data are set out in the Privacy Charter published on the website www.iame-motorsport.com

Art.7 - Applicable law and competent court

Any dispute relating to the activities of KC Mariembourg is governed by Belgian law. The courts of the district of Dinant will be the only competent courts.

Art.8 - Online sales, scope of application

Remote sales through the website www.iame-motorsport.com are concluded directly with KC Mariembourg Asbl. They are governed, when the purchaser is a consumer in the sense of the Code of Economic Law, by the provisions of this Code.

Art. 9 - Offer

The specifications of the online sales offers constitute a valid offer as long as they do not contain any material error and as long as they are visible on the website. KC Mariembourg is not responsible for offers published by means other than its website www.iame-motorsport.com

Art. 10 - Obligatory path from online purchase to consumption of the purchased ticket

Reservation of a type of title of your choice on the website www.iame-motorsport.com

Choice of a title for personal use

Summary of the order and acceptance of the general conditions of sale.

Confirmation of the purchase and payment of the purchased securities, selection of the payment method authorized by the company Acceptance or refusal of payment by the company..... After this process, the buyer receives a message from the company confirming or rejecting the payment request. The sales contract is considered concluded only in case of acceptance of the payment by the company..... All information related to the payment is exclusively transmitted through without any exchange of information with www.iame-motorsport.com

Administrative control at the time of each event. Exchange of the purchased ticket for the final access right to the event concerned.

NB : Within the framework of their relations, the seller and the buyer accept the electronic means of proof (e-mails, automatic systems recording)

Art. 11 - No right of withdrawal

In accordance with the European Directive 2011/83/EU of 25 October 2011, Article 16, paragraph I, the right of withdrawal cannot be exercised for contracts for the provision of accommodation services, other than residential accommodation, services for the transport of goods, car rental, catering or leisure activities that are to be provided on a specific date or period.

Art.12 - Type of sale

The present rules apply in full to the online sales of www.iame-motorsport.com as well as to any other type of sales.

Art.13 - Payment of an access fee

The title is payable in advance, upon reservation, online on the site www.iame-motorsport.com

The payment of online purchases will be made in euros using the payment platform (Credit card, Visa, Mastercard, Maestro, Bancontact...). The card will be debited after the customer has clicked on the "Pay" button. Customers will also have the option of paying their access fee by bank transfer as indicated on the website www.iame-motorsport.com

Art.14 - Pure and simple cancellation of a reservation

Titles reserved on the site: In accordance with article VI. 53 12° of the code of economic law (The consumer cannot exercise the right of retraction envisaged in article VI.47 for 12° the provision of services of lodging other than for residential purposes, transport, car rental, catering or services related to leisure activities if the contract envisages a specific date or period of execution), the customer does not have the right to give up his purchase. KC Mariembourg is therefore not obliged to reimburse a customer who does not show up for the consumption of his or her purchase ticket.

Art.15 - Incorrect payment

In the event of an error in online payment, the inherent costs that would be invoiced to us by the company will be re-invoiced to the customer concerned.

Art.16 - Resale of titles

The resale of KC Mariembourg's access rights is strictly forbidden and the company reserves the right to take legal action against anyone who offers official or counterfeit purchase titles for sale.
