

Terms & Conditions

1. The “IAME Series Sri Lanka” (Event) is organised by Ceylon Motor Sports Club (CMSC) and promoted by SpeedBay, owned by David Pieris Racing & Leisure (Private) Limited (DPRL), collectively referred to as “The Organiser”.
2. Competitors must submit their entries by completing the official online Entry Form. Upon receipt of the Entry Acceptance confirmation from SpeedBay, the applicable entry fee must be paid to the SpeedBay office either by bank transfer or over the counter on or before 5.00 pm on 22 January 2026. Entries are only deemed as submitted once full payment has been received.
3. The early bird entry fee offer shall be valid only until the cut-off date and time specified in the entry form. Under no circumstances shall this offer apply to any payments made after the expiry of the early bird period.
4. Competitors must meet the minimum age prescribed for their respective classes in the 2026 calendar year.
5. The minimum combined weight, including the driver, kart, and full racing equipment, shall be in accordance with the weight specified for each class. Competitors weighing less than the prescribed minimum must add ballast to achieve the required weight.
6. Competitors are strongly advised to complete an adequate number of practice sessions prior to the event.
7. Each competitor must satisfy the organiser of their competence to race. The organiser may exclude any competitor whose driving standards are unsatisfactory or for any other reason deemed fit.
8. The Organiser reserves the right to refuse the registration of any competitor without providing justification.
9. Entries will be accepted on a first come first served basis, with a maximum of 36 competitors permitted in each class.
10. Entry fee is not refundable and not transferable unless the event has been cancelled by the Organiser.
11. The Organiser may cancel the event if the number of entries is insufficient to make the event worthwhile, or due to any other circumstances beyond the control of the Organiser. In such instances, entry fees will be refunded.
12. Force Majeure: The Organisers shall not be liable for any delay or failure to hold the Event due to circumstances beyond their reasonable control, including but not limited to acts of God (such as extreme weather conditions), war, terrorism, epidemics, pandemics, governmental restrictions, labour disputes, or unavailability of critical infrastructure. Should the Organiser be forced to cancel an event for any reason, the event shall be rescheduled, and all entries received for the original event shall automatically be transferred to the rescheduled event, minus non-recoverable costs.
13. The Organiser reserves the right to recover any loss or damage caused to a go kart rented from SpeedBay and or to any equipment or facilities at SpeedBay. It is the sole responsibility of the competitor to settle such charges with SpeedBay immediately or within 5 days from the date of invoice.
14. All competitors must acknowledge that submission of the entry form includes an undertaking to comply with race regulations, house rules, and the Organiser’s decisions.
15. It is the competitor’s responsibility to ensure that they are fully aware of the published regulations and their ASRs at all times. These may be issued even during an event and uploaded to the Sportify app. The published regulations will be final and binding in the event of any dispute or during the hearing of an appeal.
16. Each competitor acknowledges that the use of a go kart is potentially dangerous and may result in serious injury. The competitor agrees to accept all such risks.
